Purpose: The Daniel Evan Zotto Keeler Scholarship is offering tuition assistance for current full time college students and who are enrolled in an accredited curriculum college course of study.

Benefit Period: College academic year of 2012-2013.

Award benefit: The scholarship is \$500.00 and will be awarded on an annual college year basis. There will be only two scholarships awarded per college academic year.

Documentation and eligibility criteria: Applicants must submit all required documentation. Check each box when you supply the required documents. This sheet must be submitted with the scholarship application.

() **Eligibility:** Applicants submitting a scholarship application must be an active member in good standing, spouse or an unmarried dependent of an active member. Active member must be a member in good standing for at least two years of the Central Chapter of the New York State Building Officials Conference.

() **Academic Requirement:** Must have a grade point average of 3.00.

() **Financial Proof of Funding:** Applicant must submit financial statements of all tuition costs for the upcoming academic year from the attended college. No financial statement, no scholarship award.

() **Letters of Recommendation:** Applicant shall submit two letters of recommendation, can be either business or personal.

() **Official Transcripts:** Only officially sealed college bearing the school official seal are acceptable. Final official transcripts are to be sent in no later than July 1, 2012. Copies, faxes, report cards, student schedules, counselor's statements, internet copies, etc are not acceptable.

Administration: Application must be made to the committee for the Fall 2012 & Spring 2013 semesters. All required documentation must be postmarked no later than July 1, 2012. Recipients will be notified as soon as possible of any approvals. Funds will be forwarded to the applicant as a soon as practical. Recipients may have their name and/or picture used by Central Chapter of NYSBOC for media uses. **This page must be submitted with the application.**
